 - From the agreement (attached):

Mr. Bissell intends to grant BFTA an easement of 25 feet along this property boundary and register this with El Paso County."
 - "BFTA will build a gate on each end of this trail and post signs indicating the Bissell Trail is for non-motorized traffic only."
 - ACTION: Larry to coordinate signage and gate construction.
 - This agreement was facilitated by Karen Marchman, who arranged the initial meeting between Mark Bissel and Larry Fariss.
