## **Ongoing Business**

- Redtail Ranch update Cheryl Pixley
  - o NES Inc. submitted revised Preliminary Plan and revised Final Plat.
  - The Plan and Plat do not include trail access to/from Linwood.
  - The Plan states that BFTA will be responsible for trail maintenance and signage. Our expectation is that no actual trail building will be needed; no grading and no installation of road base material, for example. We expect to mow the trail corridor initially and as needed, in addition to installing signs.
  - Our next step is to try to get deeds for the trail corridor from the two landowners (Didleau and Judy V) who agreed to it.
- McCune Ranch Proposal Larry Fariss
  - NES has submitted more filings (search "McCune Ranch" at EPC's site https://epcdevplanreview.com/Public/)
  - o The trail plan hasn't changed since we last saw it.
  - Terry Stokka noted in his 19 December FOBFPP email that the development is now called "Winsome Ranch".
